Minutes of the January 26, 2016 meeting of Advisory Neighborhood Commission 1-D

These minutes accepted at the March 22, 2016 meeting.

Meeting

[7:05 pm] Because of the snow emergency in the District, the Mount Pleasant Library closed at 7 pm, preventing the commission from having its scheduled meeting in the library meeting room. The commission met instead in the small meeting room at La Casa Community Center, 3166 Mount Pleasant Street. A notice was posted at the library, and people were successfully redirected to the unexpected meeting location. Nonetheless, due to the emergency relocation of the meeting, the commissioners agreed to consider only administrative matters, postponing official actions to the February meeting.

Gottlieb Simon, Director of the Office of ANCs, attended this meeting.

Public discussion

[7:05 pm] Despite the unusual location, two members of the public were present, and the meeting proceeded with an informal dialog on topics brought to the commission by them.

Call to order

[7:45 pm] Chair Agbro called the meeting formally to order at 7:45 pm. Present were all five commissioners: Adam Hoey, Arturo Griffiths, Frank Agbro, Rosa Rivas, and Jack McKay.

Treasurer's report

[7:45 pm] Jack asked if there were any objections to the following routine payments, authorized by the budget: Check to Tony Grillo, \$50, postering for the January meeting; check to the UPS Store, \$492, mailbox rent for 2016. *No objections*.

Jack noted the invoice from Dany Sigwalt for \$395.75, for services during the month preceding this meeting. *Payment approved, voice vote.*

Jack introduced the standard ANC Security Fund resolution: "Resolved that this Commission approves the ANC's participation in the Advisory Neighborhood Commission Security Fund and authorizes the Treasurer to pay the \$25 fee for the period January 1, 2016 through December 31, 2016.
