Community grants and public service funds:

Concerning community grants, ANC1D has not offered grants for several years, preferring to use its

funds for the direct purchase, or reimbursement for the purchase, of specific things that are perceived as community benefits meeting the strict requirements of the DC Code. This facilitates control over and documentation of the use of public funds.

During this 12-month period, after covering operational expenses, ANC1D has about \$10,000 surplus, available for public benefit uses..

The Fiesta del Barrio, held each year on Mount Pleasant Street by La Clinica del Pueblo, is a suitable recipient of our funds, as this annual fiesta provides free medical services to anyone who asks. In this 12-month period ANC1D paid \$4368 for the 2019 Fiesta, plus \$2164 to cover remaining expenses for the 2018 Fiesta.
