ANC1D's approach to permitting issues is to provide expert advice to applicants, to develop permit applications that will be approved by the pertinent District agency, and which are compatible with the

This ANC took stands on two extraordinary issues: abortion rights, and voting rights. After the Supreme Court Dobbs decision, ANC1D's Human Rights Sanctuary resolution, passed by unanimous vote, asserted that "This ANC . . . believes the right to make reproductive decisions is a human right that belongs solely to the person involved, irrespective of financial circumstances or place of residence". Concerning voting rights, ANC1D endorsed the measure in District Council providing local-election voting rights to legal but noncitizen residents, and advised that the right be extended to residents with TPS or DACA status.
